TMMi is the world-leading model for test process improvement. Using TMMi, organizations can improve their test process and even become accredited when they comply with the requirements.


The TMMi Foundation have set up a global assessment and certification scheme for test organizations, through local accredited TMMi assessors and lead assessors, as well as a certification scheme for test professionals offered internationally by TMMi recognized training providers.

Career Path

The TMMi career path presents two main streams:

- **Consultancy** those who provide guidance on TMMi based test improvement and lead test improvement projects.
- Assessments those who perform informal and formal TMMi assessments.

Test professionals can progress in their career and ultimately become a Certified TMMi Test Process Improver and/or accredited TMMi Lead Assessor.





TMMi and the ISTQB have entered an alliance to further promote the Software Testing profession together. The alliance brings together the people and process aspects of a test improvement program. Applying the two most important test certification schemes in conjunction strengthens the benefits for organizations and individual professionals.

- guide and advise an organization or project when using the TMMi model as a basis for their test process improvement.
- show their official certificate after passing the TMMi Professional exam.

ASSESSMENTS



is able to:

- perform informal TMMi assessments showing the strengths and weaknesses of an organization.
- provide TMMi based recommendations for test improvement.
- act as a co-assessor at a formal assessment.
- be listed on the public register available for accredited TMMi Assessors on the TMMi website and use the TMMi Assessor logo.



is able to:

- initiate and manage a test improvement project, and successfully implement TMMi in an organization or project.
- provide effective support to TMMi based improvement and deliver business value to sponsors and stakeholders.
- be listed on the public register available for certified TMMi Test Process Improvers on the TMMi website and use the TMMi Test Process Improver logo
- show their certificate whereby competence and knowledge is demonstrated through an industry-recognized TMMi certificate.



is able to:

- perform formal TMMi assessments, that provide the basis for a formal rating and can result in the company becoming certified to a given TMMi level.
- determine how well the organization's test processes compare to the TMMi best practices, and identify areas where improvements can be made.
- provide TMMi based recommendations for test improvement.
- be listed on the public register available for accredited TMMi lead Assessors on the TMMi website and use the TMMi Lead Assessor logo.
